Automotive Gas Oil (AGO)

The Automotive Gas Oil, or AGO, is the name given to fuel intended for use in road vehicles (trucks, buses, vans and cars) powered by diesel engines. AGO is used in two main types of vehicle:

- 1- Heavy-duty vehicles, such as trucks and buses
- 2- Light-duty vehicles, such as vans and passenger cars.

DIESEL (D2) - GOST 305-82

D2 is a refinery abbreviation for Gasoil. It is the second distillate from the crude, and can be used without reformers and additives. The diesel engine will ignite and combust when the pressure increases so that the heated “plug” makes it explode

GASOLINE

Gasoline, also spelled gasoline, also called gas or petrol, and also Premium Motor Spirit (PMS), is mixture of volatile, flammable liquid hydrocarbons derived from petroleum and used as fuel for internal-combustion engines. It is also used as a solvent for oils and fats. Originally a by-product of the petroleum industry (kerosene being the principal product), gasoline became the preferred automobile fuel because of its high energy of combustion and capacity to mix readily with air in a carburetor.

Gasoline is composed largely of heptane and isooctane. When you talk about an octane level of gas, the octane level is the heptane to isooctane ratio. For example with an 87 octane rating, the gasoline is 87 percent isooctane and 13 percent heptane.

Different octane ratings are best suited for different types of vehicles and have specific features that may make them more desirable to certain drivers. In order to know what type gasoline is right for your vehicle, it's important to know about the different gasoline options.

When you consider the octane level, you should know that this number relates to an average; therefore, the exact amount can be a little bit higher or lower.



AVIATION KEROSEN OIL JET FUEL A-1

JET A-1 is an aviation fuel formerly known as "kerosene" which is suitable for most jet aircraft. It meets stringent international requirements, particularly those of the latest versions of the AFQRJOS, the British DEF STAN 91-91 standard, the ASTM D1655 standard, and the NATO F-35 specification. It has a minimum flashpoint of 38°C and a maximum freezing point of -47°C.

JET A-1 is the principal fuel used for jet turbine engines. It is also used in general aviation for compatible diesel engine planes.

Kerosene-type high-quality kerosene product used primarily as fuel for commercial turbojet and turboprop aircraft engines

AVIATION KEROSEN OIL JP54

JP54 is an abbreviation for "Jet Propulsion, A1, Colonial Grade 54". During the refining process only 15% of the crude oil is made up of JP54 the rest of the grade is used for different types of plastic.

Developed by JP Morgan, Colonial grade JP54 was replaced by AVGAS also known as AVGAS100LL, it's the number one low Sulphur content kerosene used worldwide. It's gasoline!

JP54 powers gas turbine aircraft engines. Jet A and A-1 have specifications that can be used in fuel worldwide. Jet B is used in cold weather elements. Commonly a number of different mixtures make up jet fuel and this relates to flash points and how the carbon numbers are distributed.

Actually most jet fuel exported from Russia etc. is "JP54" or "Colonial JP54". It is similar to "Jet A" except the Specific Energy is 18.4 mj/kg compared to that of 42.8 mj/kg of "Jet A". Also there is a slight difference in additives. The jet fuels come in a number of flavors. There is a 100+ page handbook needed to specify them all. However, all the jet fuels relate to additives to A1, which allows the plane not to leave a white tail in the sky showing where a plane has been.

Jet fuel is kerosene, and not a distillate like Gasoil/ Diesel. In the refinery, it separates above gasolines and parafins.

Military grade jet fuel is produced by the refineries and delivered directly since they will require special additives



FUEL OIL

Fuel oil is a fraction obtained from petroleum distillation, either as a distillate or a residue. Broadly speaking, fuel oil is any liquid petroleum product that is burned in a furnace or boiler for the generation of heat or used in an engine for the generation of power, except oils having a flash point of approximately 40 °C (104 °F) and oils burned in cotton or wool-wick burners. In this sense, diesel is a type of fuel oil.

Fuel oil is made of long hydrocarbon chains, particularly alkanes, cycloalkanes and aromatics.

LPG: LIQUEFIED PETROLEUM GAS

LPG is a gas which has been converted into a liquid containing propane and butane, at low pressures and moderate temperatures, often after the cracking process.

LPG is hydrocarbon fractions which are lighter than gasoline, such as ethane, propane, and butane, kept in a liquid state through compression and/or refrigeration.

LPG differs from other petroleum products in that it turns to liquid under pressure and vaporizes or becomes burnable when the pressure is released.

LPG is a gas which has been converted into a liquid containing propane and butane, at low pressures and moderate temperatures, often after the cracking process.

LNG (LIQUEFIED NATURAL GAS)

LNG is a natural gas that has been converted to a liquid through cooling to -260°F at atmospheric pressure. LNG is formed by cooling natural gas to approximately -260°F, which converts it into a colorless liquid.

LNG is natural gas that is chilled at extremely low temperatures, so that it can be transported easily.



BASE OIL

Also known as lubes, Base oils are one of the specialty products that can be produced by a refinery.

Base oils are not a fuel. They are blend stocks used to formulate a variety of lubricating oils for use in engines and other machinery.

Base oils are produced by extracting and treating high-viscosity material from narrow distillation cuts of vacuum gasoil or vacuum residue. This requires special processing through a number of different units comprising the lubes plant.

Producing base oil is typically very profitable for a refinery, because it allows the refiner to take some of the lowest valued part of crude oil, vacuum gasoil, or vacuum residue, and sell it as a high-valued specialty product. However, base oil production facilities have a relatively high capital cost per barrel, so only a subset of refiners have installed them.

Base oils are used to manufacture products including lubricating greases, motor oil and metal processing fluids. Different products require different compositions and properties in the oil. One of the most important factors is the liquid's viscosity at various temperatures.

MAZUT

Mazut is a heavy, low quality fuel oil, used in generating plants and similar applications. In the United States and Western Europe, mazut is blended or broken down, with the end product being diesel.

Mazut-100 is a fuel oil that is manufactured to GOST specifications, for example GOST 10585-75 (not active), GOST 10585-99 Oil fuel. Mazut. Specifications (active, last modified 07.01.2010). (GOST is the Russian system of standards, much like ASTM, or ANSI, for example). Mazut is almost exclusively manufactured in the Russian Federation, Kazakhstan, Azerbaijan, and Turkmenistan. This product is typically used for larger boilers in producing steam since the BTU content is high. The most important consideration (not the only consideration) when grading this fuel is the sulfur content, which can mostly be affected by the source feedstock.

BITUMEN

Bitumen is known for its waterproofing and adhesive properties, and is created through the crude oil distillation process. The process removes lighter crude oil materials such as diesel and gasoline, and leaves the heavier bitumen behind. The process is often repeated several times to get the finished product.

BITUMEN PENETRATION GRADE 50/70 is a standard penetration grade Bitumen usually used as a Paving Grade Bitumen suitable for road construction and for the production of asphalt pavements with superior properties.

BITUMEN PENETRATION GRADE 20/30 is a standard penetration grade Bitumen usually used as a Paving Grade Bitumen suitable for road construction and for the production of asphalt pavements with superior properties.

BITUMEN PENETRATION GRADE 60/70 is a standard penetration grade Bitumen usually used as a Paving Grade Bitumen suitable for road construction and for the production of asphalt pavements with superior properties.

BITUMEN PENETRATION GRADE 70/100 is a standard penetration grade Bitumen usually used as a Paving Grade Bitumen suitable for road construction and for the production of asphalt pavements with superior properties.

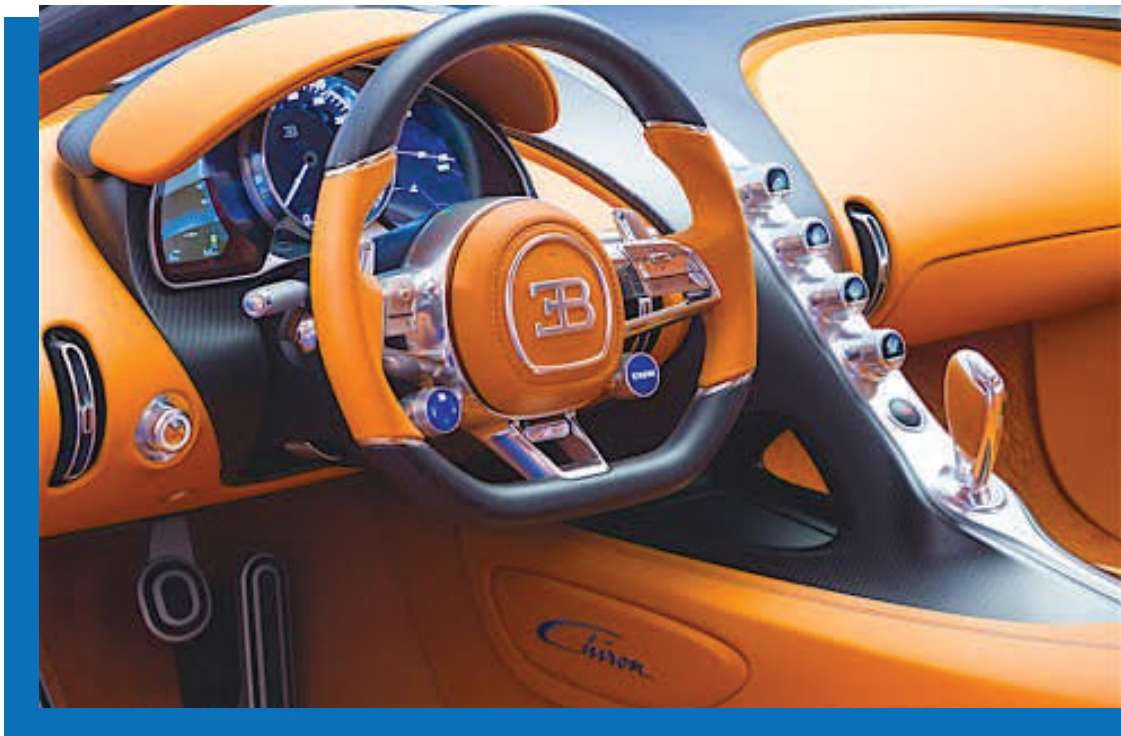

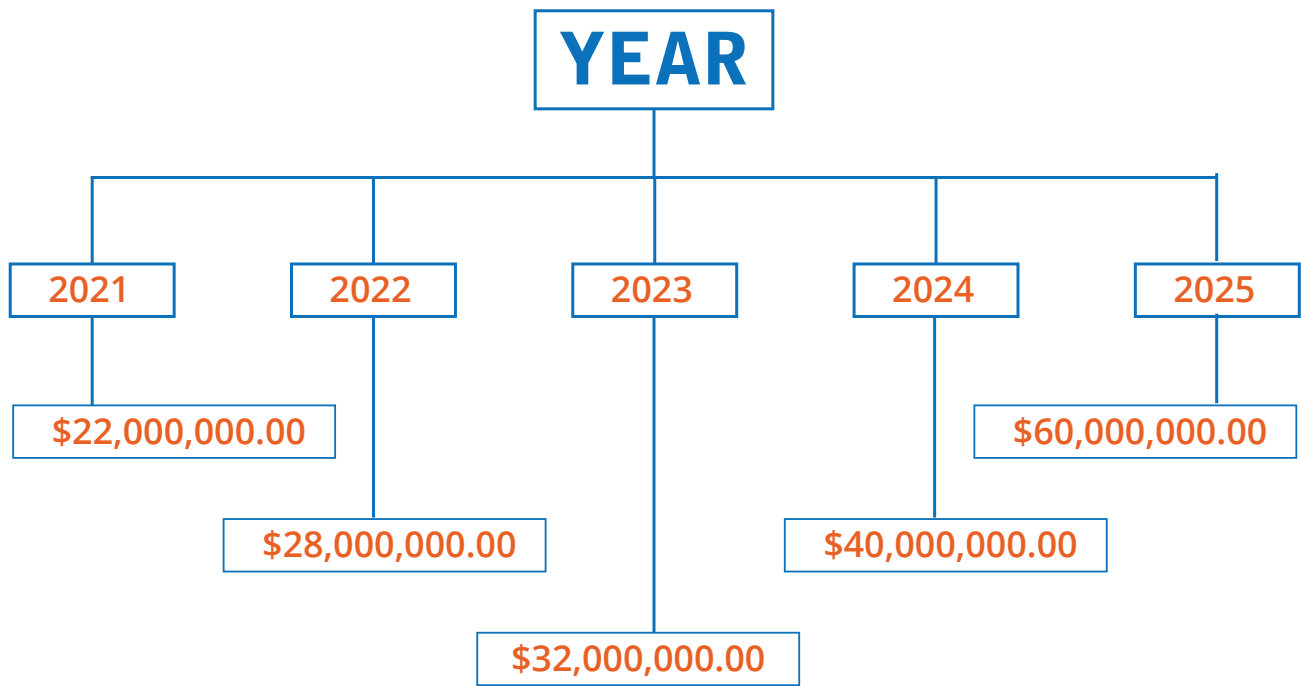
